Topics include: supervising a housing unit, officer safety and professionalism, and inmate care, custody, and control. | | | | DUI TRAFFIC STOPS This course provides an overview of the DUI problem, DUI detection, drug-impaired driving, the Standardized Field Sobriety Tests, and DUI report writing. Legal issues regarding DUI traffic stops are also discussed. | | | |
