

PROPERTY MANAGEMENT

Associate in Science Degree (CIP# 1552150100)

The Property Management Associate in Science (A.S.) degree at Valencia College is a two-year program that prepares students to work in the residential property management field. Students are trained to become highly qualified managers and other on-site personnel to help manage and operate residential rental properties.

The curriculum was developed with guidance and input from respected educational and industry leaders in the property management field. Students will learn about basic functions and effective management practices related to residential property management, including best practices for leasing and marketing properties, common procedures for maintaining residential properties, legal and ethical issues, human resource functions, finance and accounting operations, and effective communication skills.

Valencia's Property Management program has been endorsed by the National Apartment Association's Education Institute (NAAEI), the Apartment Association of Greater Orlando (AAGO), and the Institute of Real Estate Management (IREM). These endorsements, along with strong support from established leaders in the residential property management field, gives students an opportunity to earn respected industry certifications, as well as gain valuable work experience through the program's internship requirement.

Upon completion of the program, students will have the opportunity of earning both the National Apartment Leasing Professional (NALP) certificate and the Certified Apartment Manager (CAM) certification—value added credentials recognized by the property management industry.

Prominent program sponsors include: Concord Rents, the Apartment Association of Greater Orlando (AAGO), the Institute of Real Estate Management (IREM) and the National Apartment Association (NAA).

Although scheduling may not always provide for the following progression of courses, students should use the foundation, intermediate and advanced course sequence as a guide in program planning. Students are strongly encouraged to consult a career program advisor in the department office for assistance in determining the best education plan for their career goals.

All degree-seeking students must satisfy entry testing requirements and satisfactorily complete all mandatory courses in reading, student success, mathematics, English, and English for Academic Purposes in which the student is placed.

Alternative Ways to Earn Credit

You may be eligible to receive credit toward this degree if you are currently employed in the industry and have earned one of the following approved credentials (ARM, CAM, CAPS, CPM, or NALP). Start Right

Degree-seeking students enrolling at Valencia for the first time will have a limited range of courses from which to choose for their first 18 college-level credits. Within the first 18 college credit hours, you will be required to take ENC1101 (3 credits), and if applicable, SLS 1122 (3 credits) and a mathematics course appropriate to your selected meta-major (3 credits). The remaining courses will be chosen from the General Education Core Courses in humanities (3 credits), science (3 credits), or social science (3 credits), and/or the introductory courses within the A.S. degree programs. Property Management Specialist

Technical Certificate

This program is designed for students who have a desire to manage commercial and multi-family residential properties. This program will provide students with information pertaining to laws that affect property management, students will learn how to effectively lease and market properties, and they will also learn about issues that impact security and risk management. Students who complete this certificate will be eligible to earn two industry credentials awarded by the National Apartment Association. The first is the National Apartment Leasing Professional (NALP) and the second is the Certified Apartment Management (CAM) certification. To earn the NALP, a student would need to complete a 3 credit hour Residential Property Management Internships. To earn the CAM, a student would need to complete a 6 credit hour internship.

Program Outcomes

- Students will exhibit an understanding of industry standards for marketing, demonstrating, and leasing property management.
- Students will distinguish between discriminatory and non-discriminatory practices pertaining to marketing, leasing, and resident relations.
- Students will be exposed to industry best practices.
- Students will learn the basic fundamental steps to property management notifications within the Florida Landlord Tenant Act.
- Students will learn and practice different property inspections, identifying security and minimizing risk.

- Students will be exposed to a wide range of maintenance situations and how those items are reflected in financial reports and ultimately budgeting.
- Students will be prepared for entry level positions within the industry and expand their awareness of property management opportunities.
